Summary: The current MAR.CIR. provides the G-B International Ships Registry coordinates for addressing "Blue Cards", as per proceedings foreseen by MAR.CIR. 02/2022, which informed all interested parties on the list of P&I Clubs or Insurers approved by the G-B I.S.R. for the issuance of financial securities.

Purpose
