## MARINE CIRCULAR 206.1

**To: MARITIME INDUSTRY AUTHORITY (MARINA) OF PHILIPPINES**  
**DEPUTY REGISTRARS, SHIPOWNERS, SHIPMANAGERS, DPAs, FLAG STATE INSPECTORS, ROs**

**Subject: RECOGNITION OF CERTIFICATES OF COMPETENCY ISSUED BY THE PHILIPPINES MARITIME ADMINISTRATION**

### 1. Reference

1.1 Regulation I/10 of the International Convention on “Standards of Training, Certification and Watch-keeping for Seafarers (STCW)” 1978, as amended.

### 2. Introduction

2.1 This Marine Circular provides attestation for recognition of Certificates of Competency (CoC) issued by the Philippines Maritime Administration (MARINA), in accordance with the provisions of Regulation I/10 of The International Convention on Standards of Training, Certification and Watch-keeping for Seafarers, 1978, as amended (STCW), to recognize certificates and issue Palau Flag State Certificate of Endorsements (CoE) to a Master, Officer, GMDSS Radio Operator or other applicable seafarer, who are certified by the Philippines Maritime Administration.

### 3. Applicability

3.1 The present Marine Circular applies to all commercial ships and yachts registered under Palau Flag.

### 4. Information

4.1 Palau Flag Administration attests the recognition of the Certificates of Competence issued by the Philippines Maritime Administration.

Seafarers who hold a valid COC issued by the Philippines Maritime Administration and have a Certificate of Endorsement (COE) issued by Palau Flag Administration are allowed to serve onboard Palau flagged vessels.

Palau Flag Administration recognizes COCs issued by the Philippines Maritime Administration, on the basis that complete information as prescribed in article IV and section A-1/7 of the STCW Code has been communicated by Philippines Maritime Administration to the Secretary General and such information is confirmed by the Maritime Safety Committee that full and complete effect is given to the provisions of the Convention.
