#### To: SHIPOWNERS, MANAGERS, AND DEPUTY REGISTRARS

### Subject: AUTHORIZED RECOGNIZED ORGANIZATIONS AND RECOGNIZED SECURITY ORGANIZATIONS

- 1. Reference
  - 1.1 Palau Maritime Regulations Section 5.17
- 2. Purpose
  - The purpose of this Marine Notice is to inform about the organizations that 2.1 the Republic of Palau has entrusted to survey, audit and certify under the provisions of the relevant regulations of the Conventions to which the Republic of Palau is a signatory.
- 3. Requirements
  - 3.1 The Palau Ship Registry Administrator has, through contract agreement, authorized ROs and RSOs to perform the requisite surveys, inspections, audits and assessment to verify compliance with the Mandatory Instruments and National Regulations.
  - 3.2 ROs and RSOs can also withdraw, cancel or invalidate the statutory certificates issued on behalf of Palau, as a result of surveys, inspections, audits and assessment as well as PSC performance report results. Reinstatement of such certificates needs to be informed to the Palau Ship Registry Administrator accordingly.
- 4. Recognized Organizations and Recognized Security Organizations
  - The following organizations has been authorized to carry out statutory 4.1 survey, audit and certification for Palau registered vessels and audit and certification of Companies operating Palau registered vessels:

  - Depending on the number and nature of the deficiencies, the RO may 5.2 conduct an additional or conditional audit of the Safety Management System
