Subject: Invoicing Process of SIRB & COE

Dear Deputy Registrars

Further to the continuous improvement of our services, we are glad to inform you that, from January 13th 2024, onwards, all Seafarer Identification and Record Books (SIRB) and Certificates of Endorsement (COE) will be invoiced cumulatively by the end of the applicable month for the volume during the month.

1. In particular, the unit price per SIRB is USD 50.

SIRB Monthly Volume Discounts:

- 25 or more SIRB: 5% Discount
- 50 or more SIRB: 10% Discount
- 100 or more SIRB: 15% Discount
- 200 or more SIRB: 20% Discount
- 300 or more SIRB: 25% Discount
- 650 or more SIRB: 32,5% Discount
- 800 or more SIRB: 35% Discount

2. In regard to COEs the unit prices are as per below:

- Seafarer Identification & Record Book: USD 50
- Certificate of Endorsement for Master or any other officer: USD 130
- Certificate of Endorsement for GMDSS operator: USD 100
- Certificate of Endorsement for Tanker, Passenger or Ship Security Office: USD 100
- Certificate of Endorsement for Watchkeeping Ratings: USD 80

- 10 or more COE: 5% Discount
- 50 or more COE: 10% Discount
- 100 or more COE: 15% Discount

Any other discount policy regarding seafarer documentation is considered obsolete from January 13th 2024, onwards.
